Mia navigates complex relationships and supports parties in achieving practical and creative solutions while improving relationships. An all-round conflict resolver and preventer, Mia's specialisations include Technology, Energy & Environment, Workplace and difficult disputes. She is particularly useful wherever there are complex relationships and topics.

Mia mediates in a number of contexts as well as training people on how to have difficult conversations and use mediation skills to prevent disputes at work whilst promoting diversity of opinion which has been shown to lead to better results.

Mia practised EU and International trade law advising FTSE 100 companies for over seven years in the London office of a leading global law firm. She further worked for several years on two of the world's leading energy efficiency programmes, advising the UK and US Governments on the development and negotiation of environmental regulation, including some of the most sensitive legislation in that area in the US.

Born to an English/Scottish mother and Turkish father and having lived in six countries, Mia is passionate about culture, identity and conflict resolution. She frequently speaks on those and other topics, including at Chatham House.

As part of her previous role, Mia also advised the US Department of Energy on using a meditated process to develop controversial legislation. Her role for the Church of England was to facilitate shared conversations on human sexuality including LGBT issues and gay marriage. While more recently Mia has immersed herself in the task of facilitating high level European conversations around the humanitarian dimension of the refugee crisis. Whether assisting company CEOs in developing new strategy and changing their organisational culture, or creating a neutral platform for dialogue around some of today's most testing global challenges, creating intelligent solutions which are sustainable, lies at the heart of all Mia's work.

With an academic resume which includes a Masters in EU Law from the College of Europe, Bruges and a Masters of Science in Environmental Technology from Imperial College London, as a Trilingual (English, French, Italian) lawyer, she took a sabbatical in the European Commission's former "Diplomatic Corps" (External Relations) and was appointed temporary desk officer for Brunei Darussalam. A desire to be of service is central to Mia's outlook, and she counts the 3 years she spent volunteering at Camden Mediation Services helping local people to resolve neighborhood disputes, as some of her most valuable and rewarding learning. Mia is CEDR accredited (commercial and workplace mediation) and accredited to resolve faith-related disputes.
